B. Call to the Public

Dr. Celestino Fernandez asked if anyone from the public wanted to address the Governing Body. No member of the public addressed the Governing Body.

C. Review & possible adoption of March 3, 2020 Meeting Minutes

Minutes sent to Governing Body to review in advance of the meeting. Dr. Celestino Fernandez asked if there were any questions or changes. No questions were posed.

D. Presentation & possible adoption of SY20-21 School Handbooks

E. Presentation & possible adoption of the usage of Tallo

John Navarro described the Tallo platform, safety features, opportunities, and how Insight Academy of Arizona will use with HS students.

Dr. Celestino Fernandez asked if it was available only to high school students. John Navarro said the site requires a minimum age of 13 years old, so it will be geared to high school students.

Dr. Mark Duplissis inquired about how Tallo connected to ECAPS. John Navarro stated this is more of a networking tool and would not replace any portion of the ECAP.

F. Presentation & possible adoption of RISE High School Capstone Elective Credit Policy

Bouchra Bouanani explained the RISE High School Capstone for Elective Credit for returning AZVA gifted students. The project issues elective credit and independent and is supervised by RISE staff.

Dr. Mark Duplissis stated that capstone projects are essential and provide students a great opportunity to consider their pursuits after high school.

Dr. Celestino Fernandez appreciated the utilization of student journaling within the project.

G. Presentation & possible adoption of Policy for Pass/Fail Modification for Special Education Students

Dr. Celestino Fernandez stated the option of pass/fail for this group can be positive; adding that pass/fail has been utilized by many schools during the COVID-19 school closures.

I. Presentation & possible adoption of SY20-21 Prop 301 Plans (Teacher/Ancillary)

Sarah Alexander presented the Proposition 301 performance pay plans for SY20-21. Dr. Celestino Fernandez asked if teachers were happy with the plans. Sarah Alexander explained the connection to core data and practices. Kelly Van Sande explained that a task force of staff who receive Prop 301 helped to develop these models several years ago. Dr. Mark Duplissis inquired about the average payout for teachers. Kelly Van Sande stated that a full payout is 10% of the staff members' salary.

J. Presentation & review of Fiscal Year 2021 Budget

Mike Ronquillo presented the FY2021 budget describing projecting enrollment, expense and revenue breakdowns, student base funding, and the percent specific spending increased or decreased from FY2020

Senator Linda Lopez asked whether the school suspected that an increase in enrollment was connected to COVID-19 situation. Kelly Van Sande explained the factors included in projecting enrollment; schools are seeing steady enrollment but not a surge at this point. Kelly Van Sande elaborated on use of new CARES funding. Funding will support another social worker, expanding summer school, and expanding ability to provide students computers. Additionally, plans to move forward with in-person Blended Learning centers were discussed.

Dr. Celestino Fernandez stated Governing Body would not be taking action on the FY21 budget until the following meeting (July 6, 2020 at 10:00am). An opportunity to ask additional questions or provide comments was offered.
